## BUSINESS LENDING SERVICES

Competitive, fixed interest rates and terms up to 120 months (depending on the collateral) are available on loan-to-value amounts up to 90%.

**Volume Business Checking Account** – For heavy account activity. No monthly service charge with minimum daily balance of \$15,000 and more. No fees for up to 500 items\* per month. Deposit/withdraw up to \$35,000 cash per month at no cost.

**Nonprofit Association Checking Account** – The solution for associations, clubs, churches, and other nonprofit organizations. Unlimited transactions with no fees and no monthly service charges. Interest is paid monthly on a minimum daily balance of \$2,500 and more.
